## SHARED CLINICAL DECISION MAKING IN THE 2020 RECOMMENDED ADULT IMMUNIZATION SCHEDULE

## Upon completion of this activity, pharmacists will be able to:

- 1. Identify the primary reason for changes in pneumococcal vaccine recommendations in patients 65 years of age or older.
- 2. Define shared clinical decision making when considering immunization with human papillomavirus vaccine (HPV) and the 13-valent pneumococcal conjugate vaccine (PCV13).
- 3. Given a patient case, determine which vaccines are routinely recommended according to the 2020 Advisory Committee on Immunization Practices (ACIP) recommended adult immunization schedule.

## Upon completion of this activity, pharmacy technicians will be able to:

- 1. Differentiate between the 23-valent pneumococcal polysaccharide vaccine and the 13-valent pneumococcal conjugate vaccine.
- 2. Identify an age at which human papillomavirus and pneumococcal vaccines are routinely recommended.
- 3. Describe how the pharmacy technician may increase adult immunization coverage rates.
